Selectmen's Meeting Minutes August 9, 2022 - 3:30PM Unofficial Until Approved

Present: Barbara Campbell, Chairman, John Allen, Selectmen, and Frank DiFruscio, Selectmen

- 1. Chairman Campbell called the meeting to order.
- 2. The Pledge of Allegiance was recited.
- 3. Approval of Minutes:
- a. Selectmen's Meeting July 12, 2022

Frank DiFruscio made a motion to accept the minutes as written, seconded by John Allen. All approved.

4. For Selectmen Discussion and/or Motions:

a. Friends of Library – Office Space

The Friends of the Library would like to know if electricity could be added to the office space that they are currently using at the Grey's Inn Garage for book storage. After discussion, the Selectmen agreed that since this is not a permanent space, no money should be spent on improvements. The Selectmen said that maybe the Facilities Committee could discuss this building and what it may be used for in the future.

b. North Country Council Rep. Appointments

Further clarification is required before a motion is made to appoint representatives to the North Country Council. Either two or three representatives will be appointed at the next meeting once the correct number of representatives is determined.

c. Conway Household Hazardous Waste Day – (9/24/2022)

The Conway Transfer Station (755 East Conway Road) will have a Household Hazardous Waste Day on Saturday, September 24th from 8am - 11:30am. Volunteers will not be needed. Details for the event will be attached to the minutes, and will also be on the website to determine what items they will accept.

d. Conservation Commission - Picnic Table Donation

The lowest picnic table at the Jackson Falls was falling apart, so the Conservation Commission removed it. A replacement picnic table was donated by Don Bilger. The long term plan for the Falls may not include picnic tables, but rather benches with less impact to the sensitive vegetation. Frank DiFruscio made a motion to accept the gift of the picnic table, seconded by John Allen. All approved.

e. FYI – Liquor License Request – Christmas Farm Inn

John Allen made a motion to approve the extended liquor license request for the new owners of the Christmas Farm Inn, (Mark Lahood and LBC CFI LLC) seconded by Frank DiFruscio. All approved.

f. Trustees of the Trust Funds - Funding

John Allen made a motion to authorize the transfer of \$88,500 to be deposited into the Capital Reserve Funds and the Expendable Trust Funds as follows:

Fire Department Truck CRF (0003) article 5 for \$80,000, Revaluate Town Property CRF (0004) article 5 for \$3,000, Fire Department Equip. ETF (0046) article 6 for \$3,000, Meloon Groundwater ETF (0071) article 6 for \$2,000, and Town Office Equipment ETF (0047) article 6 for \$500, seconded by Frank DiFruscio. All approved.

Frank DiFruscio made a motion to withdraw \$351.48 from the Bridge Repair Capital Reserve Fund (0034) transaction # 2794639 for Lowe's dated 7/14/2022, and \$1,125.00 from the Mark Hammer Police Department Fund (0073) Invoice/Email Dated 7/18/2022 for Dirigo Readiness Resources Group, LLC, seconded by John Allen. All approved.

g. Bartlett / Jackson Ambulance

There was an incident that happened at Story Land. There were several emails that explained the incident, and the Selectmen feel that no action or meeting with Bartlett is required at this time. Kevin Bennett, who had some knowledge, agreed that the ambulance handled the issue properly. A quarterly Bartlett/Jackson Ambulance meeting will be scheduled in the near future.

h. Fire Department Generator

John Allen made a motion to place the order for the generator at the Fire Station for \$71,000, seconded by Frank DiFruscio. All approved.

Why Should You be Concerned?

The average household throws 15.5 pounds of hazardous materials into the trash each year. Household hazardous materials are disposed of in other ways, too. Certain products, such as used oil, are frequently poured down storm drains and many products end up going down the sink drain to septic systems or sewers.

Flammable or reactive household chemicals can release toxic fumes or even explode if they are mixed together in the trash, causing fires or injuring workers. Dumping solvents into septic systems or landfills may contaminate ground and surface waters ruining drinking water and killing fish and wildlife. Pesticides can damage sewage treatment plants, and oil poured into storm drains can flow directly into streams and ponds.

There are also certain health threats associated with some of these products. Products like lye can bum skin, eyes or respiratory passages. Exposure to some pesticides, paints and solvents can cause weakness, confusion, dizziness, irritability, headaches, nausea, sweating, tremors and convulsions. Other repeated chemical exposures can cause cancer or birth defects.

Children are also vulnerable to these products and accidental poisonings can occur if these products are not properly stored. In New Hampshire, the third and fourth leading causes of poisoning are personal care products and cleaning substances behind prescription and nonprescription drugs. These substances should be stored safely and, if not used, disposed of properly.
