


Selectmen's Board Meeting

May 11, 2017

Chairman Bob Thompson called the meeting into public session at 3:10PM.

1. **Swearing in of Police Officers** – Garry Sherry and Nathan Boothby sworn in and blessed by the Department Chaplain
2. **Amend & approve minutes**

4. **Public Comments** – Bea Davis heard a rumor that they were going to pave the parking lot at the Falls. Selectman Thompson said it's just something in preliminary discussion. Bea hoped it didn't get done because it's supposed to be a rural area. James Gleason noticed that the Porta Potty is further back in the parking lot and wondered if that was going to be the permanent position. Selectman Thompson confirmed that was the decision made at the end of last season.

- c. Up near Thorn Hill Inn back in the 90's there was an oil spill. 3 of the wells tested positive for contamination. Kevin is checking to see if everyone was notified at the time.
- d. There's been some illegal dumping at the old dump. There are two signs. One says No Dumping but another says Dump Here Selectman Thompson said let's make correcting the signage an Action Item.
- e. Selectman Bennett had some question as to what's been permitted for work at Nestlenook. He also had questions about a possibly illegal outhouse on Carter Notch Road. Selectman Bennett wishes it looked into.
- f. Kevin checked the gate at Nestlenook and couldn't get the gate to open. Selectman Thompson wants to send them written notice. Julie and Julie to send something.
