Selectmen's Meeting October 9, 2018

Present: Richard Bennett, Chairman; John Allen, Selectman

1. The meeting was called to order at 3:30pm.

2. Approval of Minutes:

- a. September 25, 2018 **Selectman Allen, seconded by Chairman Bennett, made the motion to approve the minutes as written. The motion passed unanimously.**
- b. Non-Public Session September 25 RSA 91-A:3, II (c) **Selectman Allen, seconded by Chairman Bennett, made the motion to sign the sealed minutes. The motion passed unanimously.**

3. Update on Action Items:

Chairman Bennett reported the following permits:

5. New Business:

- a. **Profile Rock Tree Cutting** There has been a request from abutting residents to cut 42 trees on the Profile Rock property owned by the town. Chairman Bennett read into the minutes a letter received from Chris and Lynn Caloggero (see attached). David McNeil stated he is an abutter above the Profile Rock property and the Caloggero's are on Balsam Drive. Chairman Bennett read Mr. McNeil's letter into the minutes (see attached). He then asked to hear from the Conservation Commission on the issue. Mark Ross-Parent stated he is curious about the town protocol in regards to cutting trees on town property. Bill Terry had questions from the Conservation Commission Chair: would the town use a certified arborist, and does the town want a better/interpretive sign for the site going forward so to highlight this town property. Jay Henry stated that the town has always mowed this property. He was told by Ed Dubie that the town has been maintaining that property for several years and Jay continued to do so when he was on the highway department. Mr. McNeil stated that all the trees have been marked in terms of what ones they want cut. Chairman Bennett said in the past trees have been topped and not cut down completely. Chairman Bennett asked the Conservation Commission to go up to the property and assess the trees and get back to the Selectmen. Mr. McNeil stated it was okay for them to go on his property.
- b. **Fuel Bids** Three bids were requested and only 2 received, one from Jesse Lyman and the other White Mountain Oil. The town will sign a year contract with White Mountain Oil as they had the better pricing.
- c. **Trustees of the Trust Funds** Chairman Bennett read the following request into the minutes: The Board of Selectmen are requesting the follow withdrawals from the Trust Funds as indicated below: \$1,077.18 from the Police Department Equipment Expendable Trust Fund (0051) see attached. Moore Medical Dated 9/18/18 Order #50632727. **Selectman Allen, seconded by Chairman Bennett, made a motion to sign the withdrawal request. The motion passed unanimously.**

d. **Town Policy Update** – Chairman Bennett read the policy into the minutes as follows:

"Town Policy for Boards, Commissions, and all Town Employees. Accessing Legal Assistance: If a board, commission, or town employee, has a need for legal assistance, they should first contact New Hampshire Municipal Association. They provide free legal assistance to all NHMA members, (Jackson is a member). If the matter requires further assistance and it has been determined that Town Council should be involved, Selectmen approval is required. Your written request to the Selectmen shall include: A brief summary outlining the need, an estimate of the time required from Town Council, and a plan for updating the Selectmen if needs change." Selectman Allen, seconded by Chairman Bennett, made a motion to sign the town policy. The motion passed unanimously.

- e. **Fire Department Truck Replacement** Fire Chief Jay Henry discussed the need for a truck replacement for the fire department. The town can buy locally or go through a state bid process which has discounts up to \$8,000 lower. Jay assumes the town would pay for the truck out of the capital reserve fund. Chairman Bennett confirmed that. Chief Henry stated the truck is a 2010 and currently has 80,000 miles with front end issues that are not repairable. The new truck he is looking at is approx. \$35,000 \$40,000. Selectman Allen asked if the truck is worth keeping and Jay stated not with the front end issues. Town Administrator Julie Atwell reminded the Selectmen that they are already agents to expend so they can purchase a new truck.
- f. Old Library Chairman Bennett requested to move the Old Library discussion up from old business to discuss the idea of leasing the Old Library to the Jackson Area Chamber of Commerce. The selectmen have the authority to lease the Old Library for a year. Margie Furlong asked if the Church has a say in this. Chairman Bennett states the chamber is non-profit and he has asked the church for a meeting moving ahead with this idea. Selectmen Allen asked if there were any concerns. Margie stated that the only concern was the bathroom because the size of the septic could not handle a public restroom. Chairman Bennett stated it would not be used as a public restroom and the town will still have portapotties.

6. Old Business:

- a. **Transfer Station updates** Selectmen Allen stated they are working on scheduling a meeting. Julie Atwell spoke with Gene and a meeting was not necessary. Chairman Bennett mentioned that the person who wanted to campaign there decided not to due to traffic and safety issues. Selectmen Allen noted a punch list was being worked on. Chairman Bennett noted that the transfer station has a backhoe and they can do some of the work themselves. Julie Atwell said Burr Phillips sent a punch list of who was responsible for what so it was sorted out.
- b. **Solar Project** Chairman Bennett noted that this is an ongoing discussion and that we need help with financials. The town can get an entity to pay for it and we would be responsible to pay so much a year for the use of the energy collectors. The Whitney Center,

Town Garage and Fire Department are the town buildings that would be the best locations for solar. There will be a presentation at Town meeting or before.
