The meeting was called to order.

## **Approval of Minutes:**

June 5, 2023 Meeting Minutes

Brian made a motion to accept the meeting minutes as written, seconded by Pam. All approved.

### **Prospect Farm:**

Ken will contact Jim Innes to talk about when their crew can move the forestry gate. He will also talk to the Highway Department (which is short staffed) to see when they can do the work on the parking lot.

#### **Jackson Falls:**

# <u>Invoice for Signs from JSTF, \$900 - Post Material</u>


The signs are done, and now posts need to be purchased. Brian is looking at post options. Pressure treated 4 by 4 may be the best choice for price and availability. There was discussion on where to place the posts. Ben suggested a concrete base that could be moved back in the winter for plowing, and then moved forward (or closer to the parking lot) again in the summer during the higher volume of parking. There was further discussion on how not to disturb any roots. A resident expressed concern about digging more holes for these signs and disturbing tree roots. It was mentioned that this concern can also be addressed when the management plan is developed, which will allow the town to vote on it. Brian spoke to Gary Spears from Eastern Green, who is interested in putting the signs in. He will have knowledge on where they can go without causing a problem to roots.

Dick made a motion to approve the invoice from Jackson Ski Touring for the sign material in the amount of \$900, seconded by Brian. The motion was amended by Ken to also purchase the posts for a range of \$260-\$300. All approved. This will be paid out of the Wentworth Wildcat Fund.

Ken made a motion to allow the Commission to possibly enter into a contractual agreement, not to exceed \$2,500, with Eastern Green to insert the posts, seconded by Brian. Dick abstained, everyone else approved.

# Picnic Table Location

The broken table has been removed and the table that was in the middle section of the Falls has been relocated to the upper section, where the broken one previously was.

### Wildcat River:
