- A. Tuition Contract (High School) Candidates are lined up and will be sent to Mr. Richard. Sacha Tracy and Jessica Debow are interested. Jerry Dougherty will be the Board member that will be on the committee.
- B. Interview School Board Candidates there are two people who are interested. Darlene Ference and Mike Dufilho are the candidates.

 Ms. Anzaldi asked about experience with school boards. Ms. Ference was a teacher since 1972. She served as the teacher to the Board of Education for three years. Mike does not have any direct experience with a school board, but has been in education for 20 years. He has three children at JGS. Ms. Anzaldi reviewed the time commitments required of Board members. Mike and Darlene both feel that they are able to make the commitment. Ms. Fournier spoke about her experience with the time commitment that is required. Flexibility of meetings has been beneficial in her situation. With that information shared, she asked the candidates what other commitments they have. Mike is on the Conservation Commission and also has a full time job. Darlene was President of the MWV Kiwanis, but that commitment has ended. She is also a CASA, so there is a time commitment with that. She is retired, and has time available for the Board. Ms. Burhardt thanked both candidates.

Ms. Fournier seconded that sentiment.

Ms. Burhardt asked if they are interested in a longer term than just the temporary seat. Darlene does anticipate being on the election ballot in March. Mike was planning on being a temporary fill in. He withdrew his candidacy. He is a contractor for the school as well, and asked if that would be an issue. There is potential that he would need to recuse himself from time to time but there is no issue. Mr. Dougherty thanked both candidates. Darlene is also a library trustee, and has been through the election process. The intimidation went away once she got through the first election.

Mr. Dougherty made a motion to appoint Darlene Ference as a Jackson School Board member, Ms. Anzaldi seconded.

- 2. Audit Engagement Letter this is from the auditing company. The rate is not changing.

Mr. Richard updated on the Covid response. The communication of information is a key item. Accurate information is critical. The travel quarantine requires that you will be out for 14 days regardless of test results if you travel out of the New England area. Carroll County is in relatively good shape with Covid numbers. We are at 1.2 cases per 100,000 today. The quarantining piece is about if you have symptoms or if you are with someone who has a positive result, you need to quarantine. Ms. Dembowski has been questioned about parents who are travelling. The nurse is making sure that all people are receiving the same information.

Ms. Dembowski has been in contact with people regarding skiing. There are no answers at this time.
